- b) The period of this programme and the time spent for travel and transit will be treated as on duty.
- c) She will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency.
- d) She will not extend her stay abroad beyond the permitted period.
- f) She will leave Dhaka for New York on 17 March, 2018 or a nearer date and will leave New York for Dhaka on 25 March, 2018 or a nearer date.
