Subject: Participation in the High Level Global Conference on Universal Prohibition of Corporal Punishment to be held in Malta on 31 May-01 June, 2018.

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favor of Meher Afroze MP, Hon'ble State Minister, Ministry of Women and Children Affairs to participate in the High Level Global Conference on Universal Prohibition of Corporal Punishment to be held in Malta on 31 May-01 June, 2018.

2. The sanction will be subjected to the terms and conditions mentioned below:

- a) All expenses for the Honorable State Minister will be borne by the Government of Bangladesh.
- b) The period of this programme and the time spent for travel and transit will be treated as on duty.
- c) She will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency.
- d) She will not extend her stay abroad beyond the permitted period.
- e) She will leave Dhaka for Malta on 30 May, 2018 or a nearer date and will leave Malta for Dhaka on 02 June, 2018 or a nearer date.
