The Chairman welcomed all participants and started the Proceedings of the meeting with a round of introduction. The Chairman requested the Deputy Secretary (PLAU) to brief background and details on Technical Working Group meeting of the Local Consultative Group on Women's Advancement and Gender Equality (LCG Gender).

After the introductions, Mr. Md. Shohel Rana gave a brief background of the 02. Technical Working Group and outlined the three (3) areas of cooperation identified in the 11th LCG Gender meeting, namely gender-based violence (GBV), capacity strengthening, and the National Action Plan on the National Women Development Policy. It was highlighted by participants that LCG Gender is a resource to support MoWCA. Discussions explored MoWCA's mandate, current priorities, and scope of work, noting their focus on strengthening a nation-wide GBV prevention and response programme, prevention of child marriage, social norm change, and presence at the grassroot level. Two (2) key National Action Plans (NAPs) were discussed, namely the NAP to Prevent Violence against Women and Children and the NAP for the Implementation of the National Women Development Policy. In relation to the National Action Plan for the Implementation of the National Women Development Policy, chairman of the meeting outlined the need to map the NAP against the Sustainable Development Goals (SDG) targets, and later, integrate it with the new national system of the Ministry of Planning. Meeting participants also noted the challenge of LDC graduation, coupled with the shift to automated processes and their impact on women's economic empowerment (siting examples of the RMG sector). Chairman also mentioned MoWCA's interest in the care economy. Participants echoed the need to be able to monitor and measure progress. Gender Responsive Budget (GRB) was also mentioned, with the caveat that it is not always done according to guidelines.
